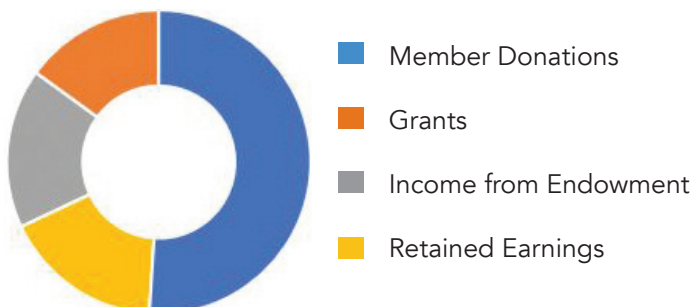

Financial Highlights

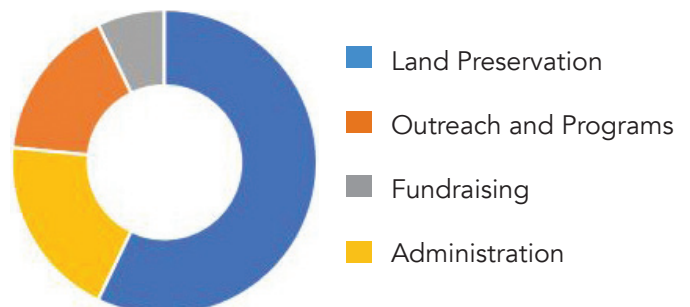

List of Accomplishments

Due to the contributions of many, including our members, donors and volunteers, much has been accomplished by CCF this year including the following:

LAND PRESERVATION AND CONSERVATION

- Planted over 65 shrubs and grasses at Menekish (corner of Old Harbor and Shore Roads), as part of Phase 1 of the restoration project and began Phase 2.
- Continued restoration work at sites on Old Queen Ann Road, Barclay Pond, and the Nickerson archaeological dig site.
- Completed study of the health of the Cockle Cove marsh.
- Frost Fish Creek Restoration designated a DER (Mass. Div. of Ecological Restoration) Priority Project. Met regularly with DOT, DER, the Town, and other partners on the project.
- Engaged with 29 land stewardship volunteers through 30 work events and related preservation projects.
- Hosted 8 AmeriCorps service projects
- With our AmeriCorps member Kas, conducted invasive species monitoring on 28 property assemblages. Completed a study of invasive plants at Barclay Pond, including an educational brochure.
- With the help of CCF members, AmeriCorps and dedicated volunteers, created a new trail at the Mill Pond Overlook off Stage Harbor Road.

OUTREACH AND PROGRAMS

- Conducted more than 10 guided walks, including trips to Strong Island, Frost Fish Creek, and a mushroom identification walk and talk.
- Collaborated with Friends of Trees, the Eldredge Library and other Cape Cod Land trusts on walks, including the inaugural First Day Hikes and annual Poetry Walk.
- Increased fundraising by over 12%.
- Awarded our educational scholarship to Charlotte Blute, a Monomoy High School graduate.
- Trustees and AmeriCorps member Kas conducted on-line and in-person education and training sessions on plant identification, invasive species, and pollinators
- Kicked off CCF's 60th anniversary celebrations with a banner at Mayo House and a historical display inside.
- Returned to having an in-person Annual Meeting, the first time since Covid
- Hosted 6 AmeriCorps members who lived at the Devine House in South Chatham for their term of service

ADMINISTRATION

- Welcomed two new Board members
- Welcomed our new Executive Director and Administrative Assistant
- In recognition of her outstanding work, named Julie Baca our Director of Land Stewardship
- Rehabilitated the second floor of the Mayo House for office and workspace for staff and volunteers
